

DRESS & BEHAVIOR CODE FOR NORTH TEXAS YOUTH CAMP

BEHAVIOR

- No foul language
- No disruptive behavior
- No alcohol, tobacco or illegal substances

MALE DRESS CODE

- No shorts or short pants
- No tank tops/capped sleeves
- No tight or revealing clothing
- No jewelry (except wedding rings)

FEMALE DRESS CODE

- Skirts or dresses only - No skirts or splits that come above the knee
- No tank-tops/capped sleeves
- No tight or revealing clothing
- No jewelry (except wedding rings)

POLICY ON WATER ACTIVITIES AND MODESTY

Campers will be required to maintain a modest appearance while participating in water activities. All campers should, at minimum, wear a shirt with sleeves and shorts that come to the knee. Garments should be dark and an effort should be made to find loose fitting materials. While traveling from water activities back to the dorm, campers should cover their clothing with a towel to hide any garment made inappropriate by the presence of water.



MEDICATION POLICY FOR NORTH TEXAS YOUTH CAMP

Policy Regarding Medication: All medications will be required to be turned in to the camp office upon arrival. They will be distributed by the camp nurse during camp and will need to be picked up upon departure.

CELL PHONE POLICY FOR NORTH TEXAS YOUTH CAMP

- Campers are permitted to have their cell phones with them except in two areas while attending North Texas Youth Camp: Dormitory and Water Areas.
- While inside the dorm, cell phones will be stored in a designated area provided and monitored by Cabin Leaders. All cell phones will be labeled on the back identifying which camper each phone belongs to. Cell phones will remain in this designated area inside the dorm until the camper is exiting the dorm.
- If a camper's phone rings/receives a text while in the designated area, the Cabin Leader will supervise the campers responding to their phones.
- If a camper is going swimming in one of the designated water areas, cell phones must remain inside the dorm until the camper returns to the dorm.
- Students who are not going swimming would be allowed to have their phones in a designated area where swimming is not taking place, and where swimming/swimmers cannot be seen.



CAMP CHAPARRAL POLICIES REQUIRED FOR NORTH TEXAS YOUTH CAMP

- Drugs, alcohol, any form of tobacco, firearms, knives or any other kind of weapon, or fireworks are NOT allowed.
- Under NO circumstances are girls to be in boys' rooms or boys in girls' rooms. Campers & sponsors will use facilities (including restrooms, showers, and dorms) according to their biological sex as determined at birth. NO EXCEPTIONS.
- Adult supervision is required at the lake and/or pool. At no time is a student to go to the lake and/or pool without adult supervision. Lifejackets are required for lake activities, regardless of a person's age or water safety ability.
- NO public display of affection (PDA) of any kind among campers.
- For the safety of students who participate in the Challenge Course (zip line, pamper pole, etc.) participants must wear closed-toe shoes (preferably tennis shoes) and no wind shorts or loose-fit clothing. Those with shoulder length hair or longer must put their hair in a ponytail or braid.
- All student vehicles must remain parked and not moved except in the case of an emergency. Students are not allowed to ride in or on any auto or recreational vehicle during camp. Additionally, keys must be turned in to the camp office upon arrival.
- After drop-off the campus will remain closed until Friday morning pickup. Only registered campers and staff will be allowed on the grounds.
